

Energy storage cell warranty policy document

When is the warranty transferable?

5.1 The warranty is transferable when the Products remains installed in its original location. This means, when the ownership of the Products has changed, the new owner shall continue to benefit under this warranty. Further, a lessee or assignee may obtain consent from the owner of the Products and make a claim under this warranty.

What if my Tesla product fails to comply with the warranty?

If your Tesla Product fails to comply with the above Limited Warranty, Tesla will, in its sole discretion, either repair your Tesla Product (using new or refurbished parts), replace your Tesla Product with an equivalent product (new or refurbished), or refund you the market price of an equivalent product at the time of the warranty claim.

How do I register for a Tesla limited warranty?

In order to register, you will need to accept the Tesla Customer Privacy Policy (). If you do not register at the time of installation, you can do so later by contacting us at the email address or telephone numbers listed at the end of this Limited Warranty.

Does Sungrow offer a warranty if I don't have a C5 enclosure?

*For systems supplied without the C5 enclosure, the PCS, and BCP warranty will be limited to 2 years if the Product is installed between 2 to 5 kilometres to the sea. Warranty is voided if the Product is installed within 2 kilometres to the sea. Warranty is valid for items supplied by Sungrow only.

How do I file a Tesla warranty claim?

For a warranty claim to be processed, it must include (i) proof of the original purchase of your Tesla Product and any subsequent transfers of ownership, (ii) a description of the alleged defect(s), and (iii) your Tesla Product's serial number and original installation date.

Who can make a limited warranty claim?

Limited Warranty claims can be made by or on behalf of the end user who acquired and put the Tesla Product into use for the first time. A subsequent owner of the Tesla Product who provides proof of ownership is also entitled to make Limited Warranty claims. Agreement to Arbitrate.
