How much does a pension insurance company pay a month in Croatia?

All the employer's payments into the third pillar of the pension insurance are not considered as salary up to EUR 66 per month/796 6,000 annually. For the company, it is a tax-recognised expenditure. Croatia provides basic mandatory health insurance to all of its residents, funded through social security contributions by employers.
