What are employers' costs in the Netherlands?

In the Netherlands there are two types of employers' costs: fixed (mandatory) and additional (optional), which add up to the total employers' costs. We list them for you. What does an employee cost? On the pay slip of an employee you often only see the gross-net calculation so you know how much salary you have to transfer to the employee.

When considering hiring an employee in Netherlands, it's important to recognize that there are additional costs involved beyond the gross salary you plan to offer.

What are employer costs?

As an employer, you don't just pay employees' salaries. There are also mandatory costs, such as holiday allowance and employee insurance, that you as an employer must take into account when hiring employees. These additional costs are called employer costs. Do you want to know exactly what an employee costs? You can easily calculate these costs.

What social security contributions do employers make in the Netherlands?

Employer Social Contributions Employers in the Netherlands are required to make several social security contributions: Unemployment Insurance (WW): This funds unemployment benefits. Health Insurance Act (Zvw): Employers contribute to the national health insurance scheme.

Do employers pay Social Security in Belgium?

If you are considering employment in Belgium, know that both the employer and the employee pay social security. Employers pay the equivalent of 25% of employees' remuneration to social security, based on total remuneration including salary, bonuses, and benefits in kind.

What are direct employer costs?

These components are seen as direct employer costs. In addition to the direct cost of employment, other indirect costs may arise in the form of employee benefits such as meal vouchers and expenses such as parking, travel, heating, electricity, and housing in the case of foreign employees.
