How has E-GP changed Bangladesh's government procurement system?

The e-GP portal streamlines the process, with over 80% of procurements now conducted online. This shift has boosted transparency and saved an estimated \$1.4 billion in 2023 alone. What are the new modules of public procurement in E-GP system?

Some new modules of public procurement have been developed and added to e-GP System. These are Tenderer Database, International Competitive Tendering (ICT), Direct Procurement, e-Audit, Framework Agreement, Red Flag Monitoring and Service Procurement.

What is a general procurement notice (GPN) in Bangladesh?

Bangladesh General Procurement Notice - A General Procurement Notice (GPN) is a public announcement by Bangladesh about upcoming procurement opportunities for goods, services, or works, inviting interested suppliers to express their interest and prepare for further bidding processes.

How has the E-GP system changed the procurement process?
