

# Solar plus storage tender price in Portugal 2026

How much does a solar auction cost in Portugal?

Portugal's second solar auction has closed with record-breaking low prices of EUR11.14/MWh(US\$13.12),or US\$0.0131/kWh,the country's government announced yesterday. Of the 700MW available for auction,670MW was awarded,with Hanwha Q CELLS winning half of the 12 lots with bids that included battery storage.

Are companies willing to pay for solar-plus-storage in Portugal?

So companies,especially companies not yet present in Portugal,have a high willingness to payfor that access," he said. The auction was the first of its kind in Portugal that invited companies to lodge bids with a storage component included,with eight of the 12 batches awarded to solar-plus-storage projects.

Solar farm in Portugal. Author: Hugo Cadavez. The ceiling price in the tender was EUR 41.54 and EUR 41.73 per MWh depending on the lots. According to the government, South Korean firm Hanwha Q Cells managed to secure six of the 12 lots, or 315 MW in total. About 483 MW of the awarded capacity will come with an energy storage element built in.

How much does Portugal pay for energy storage projects?

With this in mind,the Portuguese Ministry of Energy announced on July 31 that it was awarding EUR99.75 million to a call for tenders for the installation of energy storage projects totalling 500 MW. Eligible projects can receive up to EUR30 million and be implemented at the transport and distribution level by the end of 2025.

How many solar projects will Portugal have in 2024?

The company's six solar projectsare expected to be completed in 2024. Portugal is only realising one solar auction in 2020 as a result of the ongoing COVID-19 pandemic. As of 2021,however,the government is looking to carry out two per year,awarding a total capacity of 1GW per annum.
