

# The latest regulations of sweden s energy storage subsidy policy

What is Sweden's energy policy?

Sweden has a national energy policy target of 100 % fossil-free electricity generation by 2040. In 2022, 170 TWh of electricity was produced and the share of fossil-free was just over 98 %, see Figure 4. Electricity generation consists of: 41 % hydropower, 29 % nuclear, 19 % wind, 7 % biopower and just over 1 % solar power.

When will Swedish gas regulations be updated?

The Preventive Action Plan was updated in spring 2023, and the national emergency plan in autumn 2022. The Swedish Energy Agency has also been working on revising its regulations with a view to identifying actors in the gas market, primary consumers.

Are solar batteries tax deductible in Sweden?

Batteries that are partly used to buy and sell energy to the grid, cut power peaks or deliver support services to the electricity grid will not receive a tax reduction, according to the Swedish Tax Agency's new interpretation. When will Sweden's national energy & climate plan be updated?

The Governance Regulation (Article 14) requires the plans to be updated by 30 June 2024 and every ten years thereafter. Sweden's updated National Energy and Climate Plan (NECP) has been updated in relation to the draft that the government reported to the European Commission in summer 2023.

What is the Swedish national grid & energy agency's mandate for 2022?

On 15 December 2022, the Government gave a mandate to the Swedish National Grid and the Energy Agency to step up work on strengthening security of supply in the energy sector in the short and long term.<sup>270</sup>

Will Sweden implement Article 8 'energy saving obligation'?

The Government has instructed the Swedish Energy Agency to prepare the basis for Sweden's implementation of Article 8 'energy saving obligation', Article 10 'Alternative policy measures' and parts of Article 24 'Strengthening and protecting vulnerable customers and reducing energy poverty'.
