What is the long duration electricity storage (LDEs) cap and floor scheme?

PDF, 3.93 MB, 60 pages In October 2024, the government decided to introduce a Long Duration Electricity Storage (LDES) cap and floor scheme that will be delivered by Ofgem. The cap and floor scheme was strongly supported through consultation responses and builds on the approach already used to successfully deliver more electricity interconnection.

When will a TDD be published with OFGEM?

In October 2024 the Government's response to its Long Duration Electricity Storage (LDES) consultation set out that it would publish a joint Technical Decision Document (TDD) with Ofgem in the winter.

When will long-duration energy storage be debated?

In March 2024 the House of Lords Science and Technology Committee published a report on energy storage: 'Long-duration energy storage: Get on with it'. The report will be debated in the House of Lords on 9 January 2025. 1. What is long-duration energy storage?

What are LDEs assets?

LDES assets are based on technologies that store excess electricity that can be released when needed, therefore providing a consistent and secure supply of energy to consumers. Examples include pumped hydro storage, liquid air electricity storage, compressed air electricity storage and flow batteries. What is the cap and floor scheme?

What is the LDEs TDD?

The document provides key details on how the scheme will operate; eligibility criteria; project assessment processes; financial parameters; and next steps for implementation. The LDES TDD follows the government's October 2024 consultation response, which confirmed its intention to introduce a long-duration storage support mechanism.
